Publication Consent

Internal Publication (Inside the Classroom or Inside the School)

Video recordings of lessons or performances are also used to provide feedback to students and teachers as part of the learning process. These events take place within the school environment and are essential for achieving the school's mission. They are limited exclusively to the purposes listed above and do not require parental consent.

External Publication

There may be other instances in which student work, photos, audio and video recordings may be shared with those outside the school through means including school newsletters, the school or school board website, official social media accounts, or local media. These publications may be seen by students, families, school staff, and members of the public.

Because some of these platforms—particularly websites and social media—are publicly accessible online, content can be viewed, shared, or copied by others; There is a possibility that once posted, it may remain accessible or be redistributed beyond the school's and school board's control.

As the parent / legal guardian, you must provide your consent freely and voluntarily for the school or school board to publish, display, or share your child's work, photos, audio or video recordings for a period of up to five (5) years.

Other Publications

For any publications not previously mentioned, a new consent form will be provided for each activity.

Right to Withdraw

Withdrawing consent or refusing it will not impact access to activities. However, this withdrawal does not influence previous lawful uses. You may withdraw your consent at any time by contacting the Privacy Officer.
